CCA-sponsored AB 589 by Assemblymember Frank Bigelow (R-O'Neals) was enrolled for the Governor's signature yesterday (9-14-2017) after passing both houses of the legislature. If signed by Governor Brown, AB 589 will provide significant cost savings for ranchers who divert more than 100 acrefeet of water per year. Current State Water Resources Control Board regulations require those diverters to hire a licensed engineer to install a water-measurement device or implement an alternative measurement method, often at exorbitant costs.

AB 589 will allow diverters to instead install their own devices or implement their own measurement method upon completion of a course offered and taught by the University of California Cooperative Extension. The Governor will have until October 15, 2017 to sign or veto legislation, and CCA is strongly urging the Governor to promptly sign the bill into law. If the Governor signs the bill, it will be enacted January 1, 2018.
