California Congressmen Call for Wolf Delisting

In a letter to Principal Deputy Director of the U.S. Fish & Wildlife Service Greg Sheehan, California Congressmen Doug LaMalfa and Tom McClintock (joined by Congressmen Paul Gosar of Arizona and Rob Bishop of Utah), called for the delisting of the gray wolf, Mexican wolf and red wolf from the Federal Endangered Species List.

Citing population recovery studies, changes in the understanding of the taxonomy of some species and the complex issues surrounding wolf management, the letter urged federal delisting in favor of a more localized approach to wolf management by the individually impacted states.

UCCE to hold AB 589 Courses Around the State

UC Cooperative Extension (UCCE) will be holding various AB 589 courses throughout the state in the coming months. CCA-sponsored AB 589 allows diverters of 100 acre-feet of water or more per year to take a UCCE course and self-certify as a "qualified individual" for purposes of installing, calibrating and certifying a water diversion measurement device required by SB 88 (2015).

During these workshops, participants will learn:

• How to clarify reporting requirements for ranches

- Understand what meters are appropriate for different situations
- How to determine measurement equipment accuracy
- Develop an understanding of measurement weirs
- How to calculate and report volume from flow data

FMCSA releases guidance on 150 air-mile exemption

On Friday June 1, the Federal Motor Carrier Safety Administration (FMCSA) released guidance documents instructing haulers on the use of the current 150 air-mile exemption from hours of service for those hauling agricultural products, including livestock, and the application of the federal hours of service regulation for haulers using their vehicles for "personal conveyance." Please note, both the 150 air-mile exemption for agricultural haulers and any time not attributed to hours of service because the vehicle was being used for "personal conveyance" is only for those haulers operating in interstate commerce. CCA and livestock organizations applaud introduction of legislation addressing hours of service changes for livestock haulers

The California Cattlemen's Association, the National Cattlemen's Beef Association (NCBA) and other livestock organizations applauded the introduction of the Transporting Livestock Across America Safely (TLAAS) Act last month. This legislation would reform federal Hours of Service rules in such a way that would ensure animal welfare, highway safety and the

wellbeing of livestock haulers.

"The current Hours of Service rules for livestock haulers present big challenges for our industry and can often jeopardize the health and well-being of livestock," said NCBA President and fifth-generation California rancher Kevin Kester. "Hauling livestock is inherently different than hauling products like paper towels or bottles of water. Live cattle can't simply be left unattended in a trailer – especially in very hot or cold weather – for extended periods of time, and this bill takes that into account. Senator Sasse deserves a lot of credit for his leadership on this issue, and we thank all of the original cosponsors who stepped up to show their support for livestock haulers and cattle producers across this country."

Livestock haulers are scheduled to begin using Electronic Logging Devices (ELDs) on October 1. Adjustments in the TLAAS Act take into consideration the fact that there are live animals on the trailer that must be kept moving to arrive to their destination as quickly and safely as possible.

"Given the unique nature of livestock hauling – often very long distances between cow-calf operations and feedlots or processing facilities – and the fact that we're transporting live animals that must be treated humanely – this legislation is vitally important and I think it strikes a balance coupled with common sense for everybody involved," Kester added. "I hope Congress will pass this bill as quickly as possible so we can have this issue resolved before the ELD mandate for livestock haulers goes into effect on October 1."
