Various state and federal government programs exist to provide disaster assistance for those who have been impacted by fires. Although your attention is no doubt focused on the situation at hand, it's important to note that several of the disaster assistance programs have initial notification deadlines that must be met in order to be eligible for funding.

<u>Emergency Conservation Program (ECP)</u> - cost shares with producers who need to repair or replace fencing or water conservation structures damaged by a natural disaster. For an ECP fact sheet, click <u>here</u>.

Emergency Assistance for Livestock, Honeybees, and Farm-Raised Fish Program (ELAP) - provides emergency relief for losses due to feed or water shortages, disease, adverse weather, or other conditions which are not adequately addressed by other disaster programs. ELAP covers physically-damaged or destroyed livestock feed that was purchased or mechanically harvested forage or feedstuffs intended for use as feed for the producer's eligible livestock. Livestock Indemnity Program (LIP) - offers payments to eligible producers for livestock death losses in excess of normal mortality due to adverse weather. Eligible losses may include those determined by FSA to have been caused by wildfires, hurricanes, floods, blizzards, tropical storms, tornados, lightning, extreme heat and extreme cold. Producers will be required to provide verifiable documentation of death losses resulting from an eligible adverse weather event and must submit a notice of loss to their local FSA office within 30 calendar days of when the loss of livestock is apparent. Non-Insured Crop Disaster Assistance Program (NAP) - provides financial assistance to producers of non-insurable crops when low yields, loss of inventory or prevented planting occur due to natural disasters including excessive wind and qualifying drought (includes native grass for grazing). Eligible producers must have purchased NAP coverage for 2018 crops. A notice of loss must be filed within 15 days of the earliest of the following: the date the disaster occurred, the date the loss became apparent or the normal harvest date. Livestock producers who enrolled in NAP in 2018 can submit a NAP Notice of

Loss. If the producers didn't have NAP, they can apply for lost forage production and/or increased feed costs due to a disaster under ELAP (see above). The Livestock Indemnity Program covers livestock deaths.

<u>Tree Assistance Program (TAP)</u> - Producers whose trees or vines need rehabilitation or replacing can apply for the Tree Assistance Program. For a TAP fact sheet, click here.

<u>Emergency Loan Program</u> - available to producers with agriculture operations located in a county under a primary or contiguous Presidential or Secretarial disaster designation. These low-interest loans help producers recover from production and physical losses. For an Emergency Loan Program fact sheet, click here.

Administration Solicits Feedback on Streamlining NEPA Regulations

On June 20, the Council on Environmental Quality (CEQ) published an advanced notice of proposed rulemaking signaling its intent to update regulations implementing the procedural provisions of the National Environmental Policy Act (NEPA). Comments on the advanced notice of proposed rulemaking are due by August 20.

The proposed rulemaking, available here, lists 20 specific areas where CEQ is seeking public input on how to improve the NEPA process, primarily aimed at improving NEPA efficiency.

Reforming and streamlining NEPA analysis has been a focus of CCA and CCA's public lands permittees in recent years. At California Public Lands Council meetings held over the past year in Susanville, Sonora and Visalia, permittees have consistently identified inefficiencies in the NEPA process as the most significant issue facing federal lands ranchers; ranchers are particularly eager for the US Forest Service and Bureau of Land Management to conduct NEPA on vacant allotments so that some of those allotments might be opened up to cattle grazing.

CCA will submit detailed comments aimed at streamlining NEPA prior to the

<u>August 20 deadline, and encourages ranchers with federal grazing permits to submit comments, as well. Comments can be submitted by clicking "Comment Now!" here.</u>

Support Repeal of the 2015 WOTUS Rule

On July 12, the Environmental Protection Agency (EPA) and Army Corps of Engineers (Corps) released a supplemental notice of proposed rulemaking to rescind the 2015 Waters of the United States (WOTUS) Rule, which threatened to greatly extend the agencies' regulatory jurisdiction and impose burdensome regulatory requirements upon ranchers and other landowners. The proposed rulemaking would recodify the definition of "Waters of the United States" that existed prior to the Obama Administration's redefinition of that term in 2015.

The supplemental notice of rulemaking is intended "to clarify, supplement and seek additional comment on an earlier proposal" to repeal the 2015 WOTUS Rule, which was initially proposed on July 27, 2017.

CCA strongly supports the proposal to rescind the 2015 Rule, and filed comments to that effect in response to the initial rulemaking proposal last year (CCA's comments can be accessed here). Ranchers are encouraged to file comments supporting the 2015 WOTUS Rule's withdrawal by clicking the "Comment Now!" button here. Comments are due no later than August 13.

UCCE to hold AB 589 Courses Around the State

UC Cooperative Extension (UCCE) will be holding various AB 589 courses throughout the state in the coming months. CCA-sponsored AB 589 allows diverters of 100 acre-feet of water or more per year to take a UCCE course and self-certify as a "qualified individual" for purposes of installing, calibrating and certifying a water diversion measurement device required by SB 88 (2015).

- How to clarify reporting requirements for ranches
- Understand what meters are appropriate for different situations
 - How to determine measurement equipment accuracy
 - Develop an understanding of measurement weirs
 - How to calculate and report volume from flow data
